Biography

Baha UI Haq is an anthropologist whose research spans legal pluralism, legal Centralism or state centric legal system, gender, public health, and curriculum studies in South Asia. He holds a PhD in Social Anthropology from Quaid-i-Azam University, Islamabad. His doctoral research, *Demystifying Jirgah: Informal Dispute Resolution Mechanisms in Balochistan, Pakistan*, offers a critical examination of Pashtun customary institutions and challenges static, Weberian interpretations of *Pashtunwali*. By analysing the historical incorporation of imperial and dynastic legal traditions into Pashtun legal culture, his work reveals the dynamic, adaptive, and historically layered nature of customary law.

Dr. Haq's broader research brings together theories of legal pluralism, weak and strong legal pluralism and making distinction between juridical, customary and statutory law, gender relations, and legal anthropology. His scholarship foregrounds how dispute-resolution processes, such as *jirga*, *marakah*, *nahorah* and *dareemat* intersect with questions of authority, gender norms, state power, and community autonomy. His work also interrogates curriculum narratives, particularly the Islamisation of textbooks and the role of education in shaping political identities and legitimising central discourses in Pakistan and Afghanistan and public health.

In addition to his legal-anthropological work, Dr. Haq has contributed significantly to global health and qualitative health research and collaborated with several national and international universities and organizations.

His contributions to include qualitative research design, process evaluation, intervention translation, cultural adaptation, and field supervision. These collaborations have resulted in publications in leading journals such as *BMJ*, *International Journal of Mental Health Systems*, *Legal Pluralism and Critical Social Analysis*, *HTS Theological Studies*, and the *British Journal of Religious Education*. He also contributed to cultural preservation initiatives, working with Lok Virsa in collaboration with UNESCO on the production of a documentary titled *Preservation of Cultural Heritage: Narh-Sur in Balochistan*, highlighting commitment for safeguarding intangible cultural heritage. Across his diverse body of work, Dr. Haq's scholarship brings together rigorous anthropology, applied qualitative research, and a deep commitment to understanding how communities negotiate justice, governance, identity, and well-being. Through this interdisciplinary vision, he contributes to academic debates while supporting evidence-based policy, culturally informed development, and inclusive social transformation in Pakistan.
